**RULES**

- We will award PBA and PWBA National Titles to members winning, but the event is governed by LB Striking Against Breast Cancer
- PBA and PWBA Rules, Product Registration and Dress Code will apply for all male and female bowlers, respectively. No Exceptions.**
- All bowlers must provide 1099 information for tax purposes
- This is a scratch tournament, open to bowlers averaging 180 and above
- Practice sessions are assigned & can only change if switched with another team
- A tie for the final position going to Semi-Finals shall be broken by a 1-game roll-off, which will take place immediately following D Squad
- A tie for 8th place going to Finals will be broken by a 1-game roll-off following the Sunday Semi-Finals
- Lane patterns designed and run by a Kegel Rep
- The tournament is USBC certified
- No bowling balls may be drilled once the bowler has begun competition
- Balls used must meet USBC specifications
- Plugged balls are allowed
- Maximum of two reracks per game
- All teams are required to bowl in the Pro-Am unless excused by the tournament director.
- Tournament Directors decisions shall be final in all disputes
- Entrance into the tournament constitutes acceptance of the above rules
